## TEMPORARY PERMITS FOR COMPANIES (RED PLATES)

*These are permits for companies or entities **related to the vehicle**: manufacturers, their legal representatives, assemblers, importers, distributors and dealers, as well as official laboratories.*

**IMPORTANT:** You must book an appointment before conducting any formalities at any Provincial Traffic Department.

### GENERAL REQUIREMENTS

- **Official application form.** (*Available on [www.dgt.es](http://www.dgt.es)*)
- **Fee** of €20.20. (Payment in cash is not accepted).
- **Identification of the applicant:**
  - Natural persons: official document accrediting his/her identity and address (ID card, Spanish driving licence, residence card, Passport plus the Foreigner Identification Number).
  - Legal persons: tax identification card of the company accrediting the representation and identity of the person who signs the application (*Available on [www.dgt.es](http://www.dgt.es)*)
- Proof of the municipal licence to open an establishment for this activity (original and photocopy).
- The last receipt of payment of the Trade Tax (IAE in Spanish) charged and a photocopy or official accreditation for this activity if the applicant is a non-taxable person. In the case of **Official Laboratories**, a documentary proof of authorization for this activity issued by the relevant body.

- Fee of €8.50. (Payment in cash is not accepted).

### PERMITS FOR TESTS OR FOR EXTRAORDINARY RESEARCH TRIALS

Apart from the previous requirements, it is necessary the following:

- Proof of possession of the company's temporary permit
- To justify the need of the application.

These permits are applied and processed at the Subdirectorate General for Mobility within the Directorate-General for Traffic.

**NOTE:** *If the holder does not submit the documents, it will be necessary to also submit a written authorization signed by him/her, together with his/her original ID card, specifying that this representation is free of charge (model available on [www.dgt.es](http://www.dgt.es)).*

*The submission of documentation supporting the registration data (address) may be replaced by an express authorization so that the Directorate General for Traffic can verify such information online. For that purpose, the applicant must tick the appropriate box in the application form or fill in the express consent form available at the DGT's website or at the Traffic Departments. If DGT does not receive valid information, the applicant must submit documentation in order to remedy this situation.*

*If any of the data required above cannot be clearly proven, additional documentation could be requested*
